WHAT DOES ROCKET CARD, LLC DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"><li>- Social Security number and income</li><li>- Account balances and payment history</li><li>- Credit history and credit scores</li></ul>
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Rocket Card, LLC chooses to share; and whether you can limit this sharing.

What we do	
How does Rocket Card, LLCprotect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured filesand buildings.
How does Rocket Card, LLCcollect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"><li>- open an account or deposit money</li><li>- pay your bills</li><li>- use your Rocket Visa Signature Card</li></ul> <p>We also may collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can’t I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"><li>- sharing for affiliates’ everyday business purposes—information about your creditworthiness</li><li>- affiliates from using your information to market to you</li><li>- sharing for nonaffiliates to market to you</li></ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><li>- Rocket Card, LLC shares with our affiliates including Rocket Money, Inc., Rocket Mortgage, LLC, Rocket Homes Real Estate LLC, RockLoans Marketplace LLC (doing business as Rocket Loans), and ForSaleByOwner.com, LLC (a Rocket company).</li></ul>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"><li>- Rocket Card, LLC does not share with nonaffiliates.</li></ul>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"><li>- Rocket Card, LLC does not jointly market.</li></ul>
